



LAST DEFINITIVE RANKING LISTS SCHOLARSHIP AY 2023/2024

Now all students who applied for the Scholarship AY 2023/2024 can check the last definitive ranking at the webpage www.unibg.it > [Servizi](#) > [Borse di Studio](#) > Graduatorie.

According to the D.lgs. 196/2003 (Italian privacy law), applicants can only see their ranking by following these instructions:

- 1) Visit the web page: www.unibg.it > Servizi > Borse di studio > Graduatorie
- 2) click on **"Click here to see the Definitive Ranking - Scholarship AY 2023/2024"**
- 3) insert username and password
- 4) open the document

NUMBER OF SCHOLARSHIPS

As stated in the Call for Scholarship AY 2023/2024 (published on the webpage www.unibg.it > [Servizi](#) > [Segreteria](#) > [Borse di studio](#) > [Bandi in espletamento](#)) we allocated 850 scholarships. If the University will get extra money from the Lombardy Region, we will publish a notice on the Borse di Studio webpage around July 2024.

PAYMENT METHODS FOR SCHOLARSHIPS

BENEFICIARY students enrolled in years subsequent to the first and freshmen who got the required credits by 15/05/2024 without suspension notes, will receive the scholarship amount:

- **WHEN:** at the end of June, if the funds from Lombardy Region will be allocated on time
- **WHERE:** to the University card or to the bank account that the student inserted on the Sportello Internet by 29/04/2024
- **HOW MUCH:** the gross amount indicated in the announcement, less the first instalment for those who received it last December

OUT OF COURSE BENEFICIARY students (FUORI CORSO FC) already received the scholarship amount in a single payment in December 2023.

BENEFICIARY students with suspension notes will receive the scholarship in a single payment starting from June 2024, if the reasons for suspension no longer exist.

FRESHMEN STUDENTS

Students enrolled in the first year of a three-year or single-cycle master's degree will receive the scholarship amount after passing the OFA and achieving within 10th August 2024 at least 35 CFU (also using the 5 CFU bonus).

Students enrolled in the first year of a master's degree will receive the scholarship amount after obtaining at least 20 CFU within 10th August 2024.

The number of above required CFU is halved for part-time students.

Beneficiary students who will achieve those credits after 10th August 2024 but **within 30th November 2024** will get only the 50% of the scholarship amount.



IMPORTANT

It is not necessary to send any form to document the passing of the exams: as required by the competition notice, **the office will automatically verify the achievement of the required credits** on the following dates:

- On 15/05/2024 to receive payment starting from June, as soon as funds are available;
- On 30/08/2024 to receive payment at the end of September;
- On 15/10/2024 to receive payment at the end of November;
- On 15/12/2024 to receive payment in 2025.

CANTEEN

Eligible freshmen (*Idoneo*) will get a daily free meal in the canteen (drinks not included) after they certified the required CFU.

Beneficiary freshmen and **Eligible (*Idon*)/Beneficiary students enrolled in subsequent years** have a daily free meal at the canteen (drinks not included).

NB: The free canteen service will not be awarded until the OFA is passed.

Discounts and benefits according to the scholarship ranking are granted from 1st January to 31st December 2024, students do not need to validate the University Card.

TAX EXEMPTION

All students enrolled in subsequent years (eligible or beneficiary) are exempt from the tax payment (except for the € 156 regional tax).

Eligible students who benefit for the first year beyond the prescribed time (**FUORI CORSO**) will have to pay only 50% of the Tuition Fees.

Eligible and beneficiary Bachelor's Degree (L2)/Five-Years Master's Degree (LM5) freshmen must confirm the tax exemption by achieving, within **10th August 2024**, at least 35 CFU (also with the 5 CFU bonus).

Eligible and beneficiary Master's Degree (LM) freshmen must confirm the tax exemption by achieving, within **10th August 2024**, at least 20 CFU.

Students who will achieve those credits after 10th August 2023 but **within 30th November 2024** will have to pay the 50% of the Tuition Fees.

Eligible freshmen students who will achieve the merit requirement after 10 August 2024, not eligible students and those who are out of course are invited to check their personal area for the possible presence of invoices.
