"Hybridization techniques between verse, art and cinema in the poetry of Luis Bagué Quílez (1978). Content analysis, critical edition and translation of an anthological selection"

1) Objective:

The objective of this project is twofold: a) to analyze the work of the Spanish poet Luis Bagué Quílez (1978; Premio de la Crítica 2017) in the broader context of his literary and critical production, as well as in the context of current Spanish poetry, and investigate the rhetorical connection between poetry and visual arts expressed by the author through irony and ekphrasis; b) identify, within the author's production, a selection of texts representative of the Spanish poetic and cultural actuality and prepare an anthological compendium to be translated into Italian in anticipation of a possible publication

2) Theoretical framework:

According to a recent hypothesis (Bagué Quílez and Santamaría 2013), Spanish poetry of the last decades has undertaken at least three directions: some authors are attracted by the aspiration to fullness and perfection of language; others are placed between an elegiac cadence and a will to celebrate tradition; others have undertaken what Juan Carlos Abril has called "a third way, far from naturalism and metaphysics" (2008: 22). Such new discourses would reveal the preoccupations for an unstable reality, largely deriving from a shattered materiality and a subjectivity to be redefined. The poetry of Luis Bagué Quílez would fit into the third of the trajectories identified by Abril, being the expression of a subject who tries to build his own identity in a "Windows Context", from the title of one section of the collection *Paseo de la identidad* (2014). The first phase of the research, therefore, would assume as a methodological support the study of the theories of the subject (Scarano 2008; Mora 2016) in the current Spanish poetry, in addition to the use of the reaserches of rhetoric and pragmatics applied to the poetic discourse; the second phase, dedicated to the translation into Italian of a selection of texts by Bagué, will fall within the field of translation studies and, specifically, within the area of poetic translation with particular reference to the phenomenon of literary reception.

3) Research project description:

The first phase of the research aims to reflect on the different modes of representation of the subject and the poetic experience, led by Bagué Quílez through the rhetorical tools of irony and ekphrasis, not only pictorial, but also cinematographic. This leads not only to the intellectual attraction of the poet towards the techniques of hybridization between poetry, art and cinema, but also to the need for constant metapoetic reflection and a critical exploration of artistic creation that in a few other poetics of current Spain has reached the creative heights of Bagué. The systematical study of rhetorical

practice (condensed precisely in the figures of irony and ekphrasis) in the poetic work of Luis Bagué Quílez, will thus highlight both the theoretical reflection on an aesthetic that transcends the limits of literature to embrace the arts in general, both the consequences that this aesthetic has in the poet's production. Through a detailed analysis of the entire critical and poetic corpus of Bagué and the relevant critical literature, we intend to study the rhetorical itinerary that leads the author to reflect on the limits of the poetic language (Díez de Revenga 2015: 180), which often leads to computerized semantic drifts (emblematic in this sense is the collection *Página en construcción* of 2011). The identified interconnection will be articulated on different sequential levels: from the epistemic-cultural level of the contextualization of the artists and the texts taken into consideration, to the interdiscursive one of the interferences between poetic, pictorial and cinematographic language and finally to the interdisciplinary level of the relationship between genres. After the critical study, it will be possible to establish a significant selection of the author's poetic texts to be allocated to a translation into Italian. The theoretical reflection from Translation Studies before the practical work will allow to address problems related to aspects such as the use of different registers and intertextual references, as well as the use of rhetorical figures used to poeticize culturospecific concepts.

4) Time:

Preliminary phase (6 months): survey of the relevant bibliography; setting of theoretical system of research and bibliographic study;

Phase 2 (12 months): writing of critical essays based on the results of the research, focusing on the rhetorical aspect of the author's poetics;

Phase 3 (8 months): selection of significant poems and translation study;

Phase 4 (10 months): translation and editing of a critical apparatus and notes.

5) Expected results:

Through the analysis of Luis Bagué's critical and poetic work, it is intended to provide a significant contribution to the study of the production of one of the best representatives of current Spanish poetry, still little explored except through fragmentary studies that do not contemplate the work in its wholeness and, above all, the evolution of his writing. If Bagué has always been faithful to the aesthetic principles of formal clarity and recourse to daily life in rhetorical arguments, the latest collections and in the specific *Clima Mediterráneo* (Premio Nacional de la Crítica in 2017) affirm a strong awareness of the historical responsibility of the poet facing social and identity issues that have never been more urgent than now. With the publication of research results in foreign open-access scientific journals, the project is also part of the debate opened by international critics about the relationship between visual arts and poetry according to the theoretical perspective of visual culture (Coglitore), offering an analysis of the links between poetic and figurative art and extending it to a work in which such hybridization has not yet been deepened from a critical point of view. In fact, the ecfrastic tool emerges to summarize the personal and historical conflicts of the contemporary era, then reelaborated through irony, a genuine stylistic feature of current Spanish poetry and a figure that Bagué uses so that the excess of reality - an unbearably tragic reality - do not alter the emotional response in the reader. Finally, the translation of an anthological selection, enriched by an accurate critical apparatus elaborated with a translation studies perspective, would represent a first Italian version of the author's poetry that would help to make it known for the first time also in Italy, consolidating the results disseminated through the critical studies about his work.
