ROSSANA BONADEI is Full Professor of English Language and Literature at the University of Bergamo, Italy, where she teaches English Literature and Cultural Studies at the Faculty of Foreign Languages and Literatures. She is in the Faculty Board of the post-graduate course of Progettazione e gestione dei sistemi turistici, that she directed from 2003 to 2009, and since 2012. She is Professor in the Doctoral School of Human and Visual Studies, and actively cooperates in the international networks related to it (Interzones Doctoral School, Giessen PHDNet). She is member of A.I.A. (Associazione italiana di Anglistica) and of ESSE (European Society for the Study of English). From 2011 to 2015 she was elected Member of the A.I.A. Directing Board, being scientific co-editor of TEXTUS - English Studies in Italy.

She is author of around 100 titles of publication.

Since 2018 she is Director of the Department of Foreign Languages, Literatures and Cultures at the University of Bergamo.

Her research ranges in the contexts of literary history and aesthetic practice, as related to problems of critical theory, epistemology of literature and cultural analysis.

An expert in Landscape Studies, she has published several essays on Romantic, Victorian and Modernist poetics (Wordsworth, Clare, Hopkins, Hudson, Green), and a book on Charles Dickens, with focus on urban landscapes (Charles Dickens. Paesaggio con figure, Jaca Book, 1996). She has published translations from narrative and autobiographical texts (Forster, Dickens, G.M. Hopkins, Hudson, V.Woolf).

Another relevant topic of her research is the relationship among literature, ideology and epistemology, with special regard to the construction of 'authorship' and of 'the reading public' in Victorian and Modernist writings (Dickens, Woolf, Keynes, Orwell) : on this subject she has recently published a volume on Virginia Woolf ("Virginia Woolf. In the Nerves of Writing", Sestante Edizioni-Bergamo University Press, 2011).

She is presently concerned with travel writings and the epistemology of tourism, with focus on the "the lure of Italy" and the politics of the Grand Tour, English women travellers, Heritage Studies and the intercultural aspects of post-modern mobilities: on these topics she has published a number of essays in Italian and in English, has co-edited a volume on 'the tourist gaze' and published a book on the travel practice in the Cultural Studies perspective. ("I sensi del viaggio, Franco Angeli, 2006). Concerned with the "sense of place" are her current interests in Visual studies and Urban studies, A research on "The City"- sustained by an international network- is at the core of some latest publications.
