Call for applications for Students' Mobility (Intensive study program) in the context of ERASMUS+ Project "WAT-HER-MINES: Interpreting European Industrial Heritage" (CUP F55F21002540006), for students of the University of Bergamo regularly enrolled in the academic year 2021/2022, in the first year of the master's degree course Planning and Management of Tourism Systems.

ART. 1 – PURPOSES AND BENEFICIARIES

The project "WAT-HER-MINES: Interpreting European Industrial Heritage" involves various master's degree courses in Europe dedicated to the topic of Heritage – declined towards the valorisation of former industrial structures, and to their management as cultural heritage; the project promotes the training and the creation of joint courses dedicated to the students of the participating partners: University of Bergamo (Italy), Högskolan Dalarna (Sweden), Haute Ecole Provinciale de Hainaut – Condorcet (Belgium), Center for Urban Studies – Belgrade, Serbia).

The present call provides scholarships for Students' Mobility towards two partner institutions, where training activities such as seminars, educational excursions, participation in conferences and workshops will take place within the framework of the WAT-HER-MINES project.

During and at the end of the period abroad, students will be required to carry out projectworks consistent with the programs relating to individual mobility.

The mobility of students, coordinated by Prof. Elena Bougleux and supported by the project team (prof. Federica Burini, prof. Rossana Bonadei) will last 5 consecutive days (working days, excluding travel) and take place in each the following locations:

- Haute Ecole Provinciale de Hainaut Condorcet (Belgio), October 2022
- Center for Urban Studies Belgrade (Serbia), March 2023.

Activities during the ISP:

- Participation in the institutional/academic events
- Field trips (visits to museums, mines, rural areas, cellars, etc.)
- Meetings with experts
- Lectures
- Group work regarding the preparation for the case study reports

Activities after the mobility:

Students are required to produce reports on activities and didactic experiences carried out, related to the case studies dealt with during the mobility. The completion of the activities related to both mobility corresponds to the performance of the curricular workshop of the second year (5 CFU) and the free choice exam of the second year (5 CFU).

The University of Bergamo will select a maximum of 5 students, and provide each of them with a mobility grant, for a lump sum of \notin 2,200.00 aimed at covering mobility costs (round trip travel from the host sites, local transport, meals, accommodation).

The selected students who will carry out the mobility at the Haute Ecole Provinciale de Hainaut - Condorcet (Belgium) and the Center for Urban Studies - Belgrade (Serbia).

ART. 2 – NECESSARY REQUIRETMENS

Applicants must meet the following requirements:

1) To be regularly enrolled for the a.y. 2021/2022 in the first year of the master's degree course Planning and Management of Tourism Systems.

2) To have acquired at least 20 ECTS credits in the following disciplines: Territorial and Environment Studies, Culture and Heritage, English for Tourism and IT for Tourism Services.

3) To have willingness to carry out all the activities foreseen by the project and explained in art.1 of the call.

ART. 3 - METHODS AND TERMS FOR SUBMISSION OF APPLICATIONS

The same application, filled in and signed, must be delivered

no later than 28.06.2022 at 12.00 together with the following documentation:

- 1. Application duly completed and signed,
- 2. Curriculum Vitae European format in English,
- 3. Valid Identity document,
- 4. Letter of motivation with the reasons for the intention to carry out the mobility.

Applications received after the deadline or for which the above delivery arrangements have not been complied with shall not be considered.

The University assumes no responsibility for cases of failure or late delivery of the application, as well as for all subsequent communications related to the selection procedure, attributable to fact of third parties, fortuitous case or force majeure

Applications that do not contain all parts of the requested documentation will not be accepted.

ART. 4 - EXAMINING COMMISSION

The Evaluation Commission will be nominated by the Director of the Department of Foreign Languages, Literatures and Cultures, after the deadline for the submission of applications subsequently and made known the University website on page https://www.unibg.it/ateneo/amministrazione/concorsi-e-selezioni/bandi-studenti-e-laureati

ART. 5 - EVALUATION CRITERIA

The selection will be based on the following criteria:

1. Evaluation of the Curriculum Vitae et studiorum up to a maximum of **20 points** distributed as follows:

- Coherence of the Curriculum Vitae with the objectives and topics of the project "WATHERMINES. Interpreting European Industrial Heritage " (max 5 points);

- Study and / or professional experiences abroad (max 15 points);

2. Evaluation of the motivation letter (10 points);

3. Interview aimed at ascertaining the motivation, the preparation (on the topics described in art.1 of this call) to address the themes of the project "WATHERMINES. Interpreting European Industrial Heritage", the aptitude and willingness to participate in all the activities of the project indicated by the call for applications and the knowledge of English, up to a maximum of 70 points.

Only the candidates who have obtained a score of 18 in the evaluation of the curriculum vitae et studiorum and the motivation letter will be invited to the interview.

The minimum score for eligibility is 80/100. In case of equal merit, the younger candidate will take precedence.

The selection interview is established for 05.07.2022 at 11.30, at the University's building of Piazza Rosate n. 2 – (3rd floor meeting room)

ART. 6 RESULTS

The ranking of the selected candidates, beneficiaries of the mobility grants will be published on the web page

https://www.unibg.it/ateneo/amministrazione/concorsi-e-selezioni/bandi-studenti-e-laureati within a week after the interviews took place.

Students awarded mobility grants must inform in written the Department of Foreign Languages, Literatures and Cultures their acceptance no later than 7 days from the publication of the selection results, using the form on the web page (scanned and signed): https://www.unibg.it/ateneo/amministrazione/concorsi-e-selezioni/bandi-studenti-e-laureati



Those who do not send the communication by the due date will be considered as having renounced.

In case of non-acceptance or withdrawal, other candidates will take over according to the order of the ranking. The Office will notify the interested parties of the notice regarding the change to the email address indicated in the application form, with the deadlines by which the email of the acceptance or renunciation can be sent to the address lingue@unibg.it

Such communication will have the value of official communication, the successor candidate is therefore required to respect the terms indicated, under penalty of forfeiture of the right to assignment.

In case the student beneficiary of the mobility grant do not take part to the mobility activities in the framework of the project, she/he must refund to the University of Bergamo the full amount of the grant received

Non EU students holding a valid residence permit in Italy who should apply for a entry Visa to one of the host Countries, will be granted only after obtaining the Visa required

The insurance policy for accidents and civil liability charged to the University guarantees the insurance coverage to each beneficiary during the training activities abroad. For travel insurance and for health coverage, each beneficiary must provide him/herself with the insurances. Each student beneficiary of the grant should bring with her/him the T.E.A.M. – European Health Insurance Card.

ART. 7 - RECOGNITION OF FORMATION ACTIVITIES

It is possible to valorise the activities carried out within the project in terms of Formation Credits (as laboratory activities or courses included in the teaching plan of the PMTS Masters Course). The academic board in charge of the Masters Course, will assess the adequacy and recognize in terms of ECTS the activity carried out by the students within the project "WATHERMINES. Interpreting European Industrial Heritage".

ART. 8 – PERSON IN CHARGE FOR THE PROCEDURE

ART. 9 – INFORMATION NOTICE CONCERNING DATA PROCESSING
