**CALL FOR PARTICIPATION
to**

**THE INTERNATIONAL SUMMER SCHOOL
"WATERSCAPES in HERITAGE and ENVIRONMENT"
North Adriatic, Croatia 1-8 JULY 2023**

Organized by the University of Bergamo (Department of Foreign Languages, Literatures and Cultures), the University of Belgrade (Institute for Philosophy and Social Theory), the Institute for Social Research Zagreb, and the University of Rijeka.

The Summer School **"WATERSCAPES in HERITAGE and ENVIRONMENT"** addresses the issues of sustainability in tourism and in the management of cultural and natural heritage with the methodology of action-research, proposing an intensive week of seminars, visits, and group works, developed along an agreed maritime itinerary.

The visits and seminars of the Summer School explore the main core themes:

1. Archeology and Material Heritage
2. Social and Historical implications of Tourism
3. Sustainability, Environment and Sea Cultures

The applicants to the Summer School **"WATERSCAPES in HERITAGE and ENVIRONMENT"** are PhD and Master Students regularly enrolled in their home institutions for the year 2022-2023, attending courses referring to at least one of the three core themes of the Summer School. The University of Bergamo will select 5 students. Applicants from the University of Bergamo must be regularly enrolled for the a.y. 2022/2023 in the master's degree course Planning and Management of Tourism Systems. The selection is subjected to change in case of withdrawal of selected students, and anyway according to availability in the waiting lists resulting from the selection process.

The Summer School takes place in the week 1-8 July 2023, departing/arriving from Opatija, Croatia. The selected participants are required to attend the entire Summer School, and all related didactic and training activities.

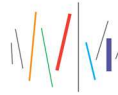
The Summer School "WATERSCAPES in HERITAGE and ENVIRONMENT" takes place on board a dedicated boat, specifically chosen and chartered by the organizers. The participation fee is € 300.00, to be paid in cash upon arrival. The participation fee includes:

- 7 nights on the boat, in a double cabin with a bathroom,
- 7 breakfasts and 7 three-course lunches,
- 6 academic seminars related to the three themes of the Summers School,
- 5 educational excursions introduced and guided by international experts,
- Group work related to the topics presented and to the visits carried out.
- Certificate of attendance issued by the home institution /by the University of Bergamo.

The fee does not include travel expenses to/from Croatia, dinners, drinks, and other personal expenses.

How to apply

The application form attached must be addressed to lingue@unibg.it and elena.bougleux@unibg.it, accompanied by a motivation letter, CV, the full list of exams taken and grades obtained, with the highlight on exams related to the themes of the school.

The application must be sent via email specifying in the subject "The Summer School WATERSCAPES in HERITAGE and ENVIRONMENT", **by April 21th, 2023 at 12.00.**

Admission process

The candidates will be evaluated by a Commission which includes the Coordinators of the activity, Prof. Bougleux (University of Bergamo) and Dr. Iguman (University of Belgrade), and members of the Scientific Committee as representatives of the thematic areas of the Summer School.

The admission criteria will consider the following:

- Academic curriculum, and exams taken and marks registered at the closing date of the call, and the grades obtained;
- Professional curriculum, only related to the school subjects;
- Language skills: proficiency in English.
- A Motivational Letter, in which the candidate explains one's personal motivation to participate in this Summer School.

The list of the selected candidates from the University of Bergamo will be published on the web page <https://www.unibg.it/ateneo/amministrazione/concorsi-e-selezioni/bandi-studenti-e-laureati> within a week after the interviews took place.

Admitted students must confirm their willingness to participate by writing to lingue@unibg.it and elena.bougleux@unibg.it within one week of the notification of admission.

Those who do not send the communication by the due date will be considered as having renounced.

In case of non-acceptance or withdrawal, other candidates will take over according to the order of the ranking. The Office will notify the interested parties of the notice regarding the change to the email address indicated in the application form, with the deadlines by which the email of the acceptance or renunciation can be sent to the address lingue@unibg.it

Such communication will have the value of official communication, the successor candidate is therefore required to respect the terms indicated, under penalty of forfeiture of the right to assignment.
