### THE CHANCELLOR

HAVING SEEN the DR rep. n. 924/2023 of 22.12.2023 announcing the public selection based on qualifications and interview for the awarding of no. 2 Early-stage grants for conducting research pursuant to art. 22 of law no. 240/2010 at the Department of Management of University of Bergamo - Pica Code: 23AR036;

HAVING ACKNOWLEDGED that following publication, the need to amend Annex A was identified;

### DECREES

#### Article 1

For all that stated in the introduction, in the context of the selection announced with DR rep. n. 924/2023 of 22.12.2023 announcing the public selection based on qualifications and interview for the awarding of n. 2 Early stage grants for carrying out research activities, pursuant to art. 22 of law no. 240/2010 at the Department of Business Sciences of the University of Bergamo - Pica Code: 23AR036, the changes to Annex A have been inserted and **the deadline** for submitting applications for admission **has been postponed from 12.00 (Italian time) of 22.01.2024 at 12.00 (Italian time) on 06.02.2024.**
