

# NOTICE OF SELECTION FOR THE PARTICIPATION AT THE DOUBLE DEGREE JOINT PROGRAM IN

# "M.Sc. Economics - European Economic Integration" (Trier University) and

"Master in Economics and Data Analysis" (Università degli studi di Bergamo) for the academic year 2024-2025

At the Department of Economics there is an agreement with the University of Trier (D) for the achievement of a double degree.

The possibility to participate is reserved to **5** students enrolled in the a.y. 2023-2024 in the first year of the Master Degree in "Economics and Data Analysis", LM56 (EDA), curriculum "Economics and Data Analysis" (ED). Attending the second year at the German university, they can achieve the degree in "M.Sc. Economics – European Economic Integration".

The purpose of this double degree integrated program is to make the students achieve a complete international training that will give them more job opportunities, in Italy as in other European countries.

The integrated study program is organized as follows: in the first year of master degree, the student will take the exams for the **60** CFU required at the University of Bergamo. In the second year, the student will complete his/her studies taking exams for **60** CFU at Trier University, of which **30** CFU related to the master thesis, which will be discussed at one of the two institutions.

Attendants to the double degree also can achieve supernumerary exams.

The study plan for the students enrolled at a.y. 2023-24 in LM EDA, curriculum ED, at the University of Bergamo, includes the following exams:

#### Requirements to participate in the selection

Being enrolled, for the a.y. 2023-2024, in the first year of the course of LM in Economics and Data Analysis (EDA), curriculum "Economics and Data Analysis" (ED), and having achieved at least **12 CFU** with exams required by the study plan by the date of the presentation of the application.

The selected applicants will be admitted definitively to the exchange program after the verification of the following conditions:

- being regularly enrolled, for the a.y. 2024-2025, at the second year of the course LM in Economics and Data Analysis (EDA), curriculum ED;
- having achieved 60 CFU by the end of the exam session of September 2024.

#### Selection

The applications will be examined by the Commission, appointed by the Council of the Department of Economics, with the purpose of verifying the possession of the requirements of participation, of evaluating the CV and the motivation of the aspiring participants.

The applicants whose applications conform to the present notice, will also have to attend an interview with the above-mentioned Commission, **the day 12 March 2024 at h. 9.30** and following. (Place and modalities will be communicated).

The criteria after which the ranking is determined will take into consideration:

- the number of CFU achieved at the date of the presentation of the application;
- the curriculum vitae of the student (in English);
- the motivation letter presented at the moment of the application (in English);
- the interview attended with the Commission.

## Results and acceptance

The publication of the ranking in the indicated modalities is worth a notification for all of the students interested; in any case, the selected students will be notified via email, at the address communicated at the moment of the presentation of the application.

By 10 days before the departure, the selected students will need to send a communication of the achieved exams at the Student Office (Segreteria Studenti, email: <a href="mailto:segreteria.economia@unibg.it">segreteria.economia@unibg.it</a>) for any related checks.

#### **Economic conditions and financial support**

Expenses for travel, food, accommodation and health insurance (see following point) are in charge of the students.

The selected applicants for the present integrated program can benefit from ERASMUS scholarships for mobility for study purposes, if they possess the requirements required by the call.

#### Insurance cover

Every beneficiary student is covered, during the formative activities abroad, by an insurance policy and civil responsibility in charge of the University of Bergamo.

For the health insurance cover, every beneficiary student must arrange with other private insurance formulas or models as required in the destination country.

#### Responsible for the procedure

According to the law 241/1990, Dr. Fausta Schiavini, Administrative Responsible of the Garrison of Economics, is appointed responsible for the administrative procedure.

### Data treatment and privacy

- 2. CV in English (dated and signed) in pdf format;
- 3. a copy of the ID card/passport.

Applications which don't present all of the required documents will not be accepted.
