Object: Annulment of public selection (code 7) based on qualifications and interview for the awarding of no. 1 Experienced grant for conducting research pursuant to art. 22 of law no. 240/2010 at the Department of Economics of University of Bergamo, announcing with D.R. Rep. n. 498/2024 of 30.04.2024 PICA code 24AR012.

THE CHANCHELLOR

- GIVEN the Statute of the University of Bergamo;
- HAVING SEEN the DR rep. n. 498/2024 of 30th April 2024 announcing the public selection based on qualifications and interview for the awarding of no. 9 Experienced grants for conducting research pursuant to art. 22 of law no. 240/2010 at the Departments of University of Bergamo Pica Code 24AR012;
- CONSIDERED that for the procedure of the research project *"Big Data Integration, Management and Modelling to study the impact of Innovation, Sustainability and Green Revolution",* identified by code 7 in the Annex A of the above-mentioned Chanchellor's Decree, the admission requirement is the possession of a PhD;
- NOTED for the code 7 procedure a discrepancy between the resolution of the Department of Economics and the resolution adopted by the governance Bords in the meeting of April 2024 with regard to the access requirements;
- RECOGNISED therefore, the need to cancel only the procedure identified by code 7 of the abovementioned public selection, safeguarding the remaining procedures, announced with D.R. rep. n. 498/2024 of 30th April 2024;
- NOTING that at the date of this decree no application to participate in the procedure identified by code 7 has been submitted;

DECREES

Art. 1

In reference to the public selection based on qualifications and interview for the awarding of no. 9 Experienced grants for conducting research pursuant to art. 22 of law no. 240/2010 at the Departments of University of Bergamo, announced with D.R. 498/2024 of 30th Aprile 2024 - Pica Code 24AR012, is cancelled the procedure relating the research project *"Big Data Integration, Management and Modelling to study the impact of Innovation, Sustainability and Green Revolution"*, identified by code 7 in the Annex A of the above-mentioned decree.
