LAST DEFINITIVE RANKING LISTS SCHOLARSHIP AY 2024/2025

Now all students who applied for the Scholarship AY 2024/2025 can check the entire last definitive ranking lists AY 2024/2025, drawn up on the basis of checks conducted on the self-certifications produced by the students.

IMPORTANT!

Sufficient funding to pay the benefit was guaranteed to all students successfully placed on the ranking list, therefore **ALL applicants in possession of the requirements set out in the announcement are considered beneficiaries.**

According to the D.Igs. 196/2003 (Italian privacy law) and art. 13 of the European Regulation n. 679/2016, applicants can see their detailed rank as follows:

- 1) Enter **Portale del Diritto allo Studio**
- 2) click on "Accedi" on the section "Esito Graduatorie"

3) click on "Visualizza esito" of the line "**Borsa di Studio - Graduatoria Borsa di Studio Definitiva** Integrata a.a. 2024/2025"

Information on the rankings will be given only to the applicants who must qualify themselves through their serial number.

Pursuant to **article 8.1** of the <u>competition announcement for the academic year 2024/2025</u>, requests for corrections/appeals must be submitted in written form by opening a ticket with *Diritto allo Studio* by 31 May 2025.

There aren't sensitive data in the ranking, the applicants can find their rank through the Application number (numero di ricevuta domanda) which is visible at the section "Ricevute"> Scarica Riepilogo, del Portale del Diritto allo studio.

All students are reminded to check the results of their application with particular attention to any suspension notes and the "status" assigned (S - local students, P - commuter students, F - long distance students).

PAYMENT METHODS FOR SCHOLARSHIPS

BENEFICIARY students enrolled in years subsequent to the first and freshmen who got the required credits by 15/06/2025 without suspension notes, will receive the scholarship amount:

- WHEN: By the end of July, if the funds from Lombardy Region will be allocated on time
- WHERE: to the personal IBAN indicated in the "IBAN" Section of the <u>Portale del Diritto allo</u> <u>Studio</u> by 03/06/2025, under penalty of forfeiture of the right to the scholarship
- **HOW MUCH:** the net amount indicated in the announcement, according to your status and your income bracket, less the first instalment for those who received it in December 2024

OUT OF COURSE BENEFICIARY students (FUORI CORSO FC) already received the scholarship amount in a single payment in **December 2024.**



BENEFICIARY students with suspension notes will receive the scholarship in a single payment starting from June 2024, if the reasons for suspension no longer exist.

Students enrolled in the first year of a three-year or single-cycle master's degree will receive the scholarship amount after passing the OFA and achieving within 10th August 2025 at least 35 CFU (also using the 5 CFU bonus).

Students enrolled in the first year of a master's degree will receive the scholarship amount after obtaining at least 20 CFU within 10th August 2025.

P.S.: The number of above required CFU is halved for part-time students.

Beneficiary students who will achieve those credits after 10th August 2025 but **within 30th November 2025** will get only the 50% of the scholarship amount.

IMPORTANT

It is not necessary to send any form to document the passing of the exams: as required by the competition notice; all the criteria and information on the payment of the scholarships are specified on page 21 and following of the <u>Competition Notice</u>

CANTEEN

The assignment of the benefits to the eligible and to the beneficiaries of the scholarship will be recognized by using the Qr Code created by the **Canteen App** <u>Unibg.EAT</u>.

Suspended students will be able to access the catering service free of charge (drinks excluded) after the reasons for suspension have ceased to exist.

TAX EXEMPTION

All beneficiary students enrolled in subsequent years are exempt from the tax payment (except for the € 156 regional tax), without sending further documentation.

Eligible students who benefit for the first year beyond the prescribed time **(Fuori Corso)** will have to pay only 50% of the Tuition Fees.

All beneficiary students enrolled in a first year must confirm the tax exemption by achieving the aforementioned credits.

Students who will achieve those credits after August 10th, 2025, and by **November 30th, 2025**, will have to pay the 50% of the Tuition Fees.
