Correction to Attachment A of the PhD Programme in Management accounting and finance and Clarification on the allocation of scholarships for the PhD Programme in Technology, innovation and management – Announcement of a public selection for admission to PhD programs administratively based at the Università degli studi di Bergamo XLI round

THE CHANCELLOR

HAVING REGARD TO Rectoral Decree no. 344/2025 of 16 May 2025, which issued the Announcement of a public selection for admission to PhD programs administratively based at the Università degli studi di Bergamo – XLI round;

ACKNOWLEDGING the identification of the following clerical errors:

- In the information sheet for the PhD Programme in Management Accounting and Finance included in Attachment A of the Announcement, the following additional access requirement was erroneously stated:
"Having obtained or being in the process of obtaining the last Master's Degree (or equivalent academic degree) within the 5 years prior to the date of the call for applications, with a Bachelor's Degree grade not less than 99/110. For undergraduates, the curricular average must not be less than 96/110"
instead of:
"Having obtained or being in the process of obtaining the last Master's Degree (or equivalent academic degree) with a grade not less than 99/110. For undergraduates, the curricular average must not be less than 96/110."
- In the table included in Article 1 of the Call, concerning the PhD Programme in Technology, Innovation and Management, the allocation of scholarships was incorrectly stated as "4 institutional scholarships" and "4 other scholarships", instead of "7 institutional scholarships" and "1 other scholarship", as correctly specified in Attachment A of the Announcement;

CONSIDERING the need to correct Attachment A of the Call to amend the identified clerical errors;

DECREES

- a) to approve the correction of Attachment A of the Announcement issued by Rectoral Decree no. 344/2025 of 16 May 2025 for the PhD Programme in Management Accounting and Finance, by replacing the access requirement:

"Having obtained or being in the process of obtaining the last Master's Degree (or equivalent academic degree) within the 5 years prior to the date of the call for applications, with a Bachelor's Degree grade not less than 99/110. For undergraduates, the curricular average must not be less than 96/110"
