# HOW TO UPLOAD DOCUMENTS FOR SCHOLARSHIP A.Y. 2025/2026

#### 1. STUDENTS WHO WANT TO BE CONSIDERED AS LONG DISTANCE WITH A RENTAL CONTRACT

WHAT: documents as listed at chapter 4.2.1. of the Scholarship competition notice.

**HOW**: after submitting the scholarship application declaring to be Fuori sede, the documents must be merged into one pdf file and uploaded in the <u>Diritto allo studio website</u>, section "Upload documents", "Contratto di affitto e registrazione".

WHEN: by 31/10/2025.

## 2. STUDENTS WHO WANT TO BE CONSIDERED AS LONG DISTANCE STUDENTS WHO HAVE MORE THAN A RENTAL CONTRACT

For students whose rental contract will end after 31/10/2025 but doesn't cover the 10 months (or 5 months, for out of course (fuori corso students) in the period indicated in the competition notice, and therefore need to upload more than a contract.

**WHAT**: documents as listed at chapter 4.2.1. of the <u>Scholarship competition notice</u> for both contracts.

**HOW**: after submitting the scholarship application declaring to be Fuori sede, the documents must be merged into one pdf file and uploaded in the <u>Diritto allo studio website</u>, section "Upload documents", "Contratto di affitto e registrazione".

**WHEN:** by 31/10/2025 it must be uploaded the documents of the rental contract valid at that moment, then, as soon as possibile and in any case **not later than 20/04/2026**, you must upload again all the documents needed for the new rental contract) in the <u>Diritto allo studio website</u>, section "Upload documents", "Contratto di affitto e registrazione".

#### CHANGES OR ADDITIONAL CONTRACTS WON'T BE ACCEPTED AFTER 20 APRIL 2026

### 3. STUDENTS WHO LEAVE FOR MOBILITY FOR LESS THAN 10 MONTHS

#### For the months abroad:

WHAT: documents as listed at chapter 4.2.1. of the Scholarship competition notice.

**HOW**: after submitting the scholarship application declaring to be Fuori sede, the documents must be merged into one pdf file and uploaded in the <u>Diritto allo studio website</u>, section "Upload documents", "Contratto di affitto posseduto all'estero durante il periodo di mobilità".

**WHEN:** by 31/10/2025 for those leaving for the I semester, by 20/04/2026 for those leaving for the II semester.

### For the months in Bergamo:

**WHAT**: documents as listed at chapter 4.2.1. of the <u>Scholarship competition notice</u>.

**HOW**: the documents must be merged into one pdf file and uploaded in the <u>Diritto allo studio</u> website, section "Upload documents", "Contratto di affitto e registrazione".

**WHEN:** by 31/10/2025 for those leaving for the II semester, by 20/04/2026 for those leaving for the I semester.

#### 4. STUDENTS WHO REQUESTED A SCHOLARSHIP INCREASE FOR DISABILITY

**WHAT**: the documents to prove special needs as requested in the <u>Scholarship competition notice</u>.

**HOW**: after submitting the scholarship application requesting the supplement, the documents must be merged into one pdf file and uploaded in the <u>Diritto allo studio website</u>, section "Upload documents", "Documentazione attestante particolari/eccezionali esigenze".

**WHEN:** by 15/01/2026

## 5. STUDENTS WHO REQUESTED THE MONETIZATION OF THE CANTEEN SERVICE FOR HEALTH REASONS

**WHAT**: the documents to prove the health reasons that prevent you from going to the university canteens as indicated in the <u>Scholarship competition notice</u>.

**HOW**: after submitting the scholarship application requesting the supplement, the documents must be merged into one pdf file and uploaded in the <u>Diritto allo studio website</u>, section "Upload documents", "Documentazione rilasciata dallo specialista del SSN".

**WHEN:** by 15/01/2026

## 6. STUDENTS WHO REQUESTED A SCHOLARSHIP SUPPLEMENT FOR INTERNATIONAL MOBILITY AND INTERNSHIPS IN FOREIGN COUNTRIES

**WHAT**: the documents to prove expenses to buy the first trip to arrive and the last trip to leave the country where the student attended the mobility program.

**HOW**: after submitting the scholarship application requesting the supplement for mobility, the documents must be merged into one pdf file and uploaded in the <u>Diritto allo studio website</u>, section "Upload documents", "Spese di viaggio per integrazione mobilità".

**WHEN:** by 31/10/2025

#### **IMPORTANT**

Any change in the uploaded documents (for example early termination of the contract or other changes) must be communicated promptly to Servizio Diritto allo studio by opening a ticket.
