# SCHOLARSHIP 2025/2026 PROVISIONAL RANKING

Now all students who applied for the Scholarship AY 2025/2026 can check the entire provisional ranking lists AY 2025/2026.

According to the D.lgs. 196/2003 (Italian privacy law) and art. 13 of the European Regulation n. 679/2016, applicants can see their detailed rank as follows:

- 1) Enter Portale del Diritto allo Studio
- 2) click on "Accedi" on the section "Esito Graduatorie"
- 3) click on "Visualizza esito" of the line "Borsa di Studio Graduatoria Borsa di Studio Provvisoria a.a. 2025/2026"

There aren't sensitive data in the ranking, the applicants can find their rank through the Application number (numero di ricevuta domanda) which is visible at the section "Ricevute" > Scarica Riepilogo from Portale del Diritto allo studio.

Information on the rankings will be given only to the applicants who must qualify themselves through their serial number.

The **provisional ranking** is based on the self-certification submitted by applicants. Following the ex officio checks, the position of the candidates may be redetermined.

# CORRECTION REQUESTS OR APPEALS MUST BE SUBMITTED IN WRITING BY OPENING A <u>TICKET</u> WITH THE *DIRITTO ALLO STUDIO* STRICTLY BY NOVEMBER 25<sup>TH</sup>, 2025.

N.B. The provisional INTERNATIONAL MOBILITY contribution ranking will be published by January 15<sup>th</sup>, 2026, while the final one will be published at the end of all exchanges.

## **IMPORTANT**

All students must check the results of their application with particular attention to:

- The "status" assigned: local (S), commuter (P), long distance (F).
- any suspension notes.

**Pendolare** (Commuter) students who uploaded their rental agreement documentation by October 31, 2025, must check the "Upload Documents" section for any non-compliance with the uploaded documentation and can supplement the documents by **25 November 2025** to be considered **Fuori Sede** (Long distance students) in the final ranking that will be published in December.

Students who are **NOT ELIGIBLE** with the reason "ISEE non valido per le prestazioni per il diritto allo studio Universitario" or with the reason "Attestazione ISEE non presentata nei termini" will be eligible for the final ranking only if:

- they have an ISEE presented by 03/10/2025;
- 2. they ask the re valuation of their rank by writing a <u>ticket</u> to Diritto allo Studio **strictly by 25/11/2025**;
- 3. they do an ISEE valid fo University by 31/12/2025 and inform the Diritto allo Studio.

#### NUMBER OF THE SCHOLARSHIP

As stated in the **Bando di concorso** we allocated 800 scholarships. If the University gets extra money from the Lombardy Region, we will publish a notice on the Borse di Studio webpage around July 2026.

#### **PAYMENT METHODS FOR SCHOLARSHIPS**

Payments will be made based on the final ranking list which will be published in December. For **beneficiary students without suspension notes**, the **first scholarship installment** will be paid by December 31, 2025.

For beneficiary students included in the ranking list as "**fuori corso**", who do NOT graduate by November 30, 2025, the scholarship will be paid in a single installment in December 2025.

All the criteria and information regarding scholarship payments are specified on page 22 of the Call for Applications.

Payment will be made exclusively by bank transfer to the **IBAN** of an account in the name of or jointly held by the beneficiary student, according to the following criteria:

- 1. An Italian or foreign account indicated by the student on the Student Internet Help Desk, in the section Home > Conto rimborso contributi-pagamento borse di studio.
- 2. In the absence of an account as per point 1, the IBAN associated with the Flash up University Card provided by the university.

Beneficiary students who wish to ensure they meet the December payments schedule must have entered their IBAN by November 30, 2025.

If the student, WHETHER ELIGIBLE OR BENEFICIARY, does NOT provide the payment details by January 31, 2026, he or she will lose the scholarship benefit for the 2025/2026 academic year.

# **CANTEEN**

Discounts and exemptions will be officially recognized based on the ISEEU / ISEEU parificato received. The assignment of the benefits to the eligible and to the beneficiaries of the scholarship will be recognized from 1st January 2026 to 31st December 2026.

### **TAX EXEMPTION**

All students enrolled in subsequent years, who are beneficiaries or eligible for the 2025/2026 scholarship, are entitled to a waiver of the comprehensive tuition fee without the need to confirm additional merit requirements.

Eligible students enrolled outside the prescribed timeframe **(fuori corso)** are entitled to a 50% waiver of the comprehensive tuition fee.

For first-year students who are beneficiaries or eligible for the 2025/2026 scholarship, the waiver of the comprehensive tuition fee is contingent upon achieving, by August 10, 2026, the following:

- 35 credits (ECTS), including the use of the 5-credit bonus for students enrolled in the first year of a bachelor's degree or single-cycle master's degree.
- 20 credits (ECTS) for students enrolled in the first year of a master's degree.

Obtaining the aforementioned credits by **November 30, 2026**, instead of **August 10, 2026**, will entitle you to a 50% exemption from the payment of the comprehensive contribution.
