SCHOLARSHIP 2025/2026 DEFINITIVE RANKING

Now all students who applied for the Scholarship AY 2025/2026 can check the entire definitive ranking lists AY 2025/2026.

According to the D.lgs. 196/2003 (Italian privacy law) and art. 13 of the European Regulation n. 679/2016, applicants can see their detailed rank as follows:

- 1) Enter Portale del Diritto allo Studio
- 2) click on "Accedi" on the section "Esito Graduatorie"
- 3) click on "Visualizza esito" of the line "Borsa di Studio Graduatoria Borsa di Studio Definitiva a.a. 2025/2026"

There aren't sensitive data in the ranking, the applicants can find their rank through the Application number (numero di ricevuta domanda) which is visible at the section "Ricevute"> Scarica Riepilogo from Portale del Diritto allo studio.

Information on the rankings will be given only to the applicants who must qualify themselves through their serial number.

CORRECTION REQUESTS OR APPEALS MUST BE SUBMITTED IN WRITING BY OPENING A <u>TICKET</u> WITH THE *DIRITTO ALLO STUDIO* STRICTLY BY JANUARY 15^{TH} , 2026.

N.B. The provisional INTERNATIONAL MOBILITY contribution ranking will be published by January 15th, 2026, while the final one will be published at the end of all exchanges.

IMPORTANT

All students are reminded to check the results of their application with particular attention to any suspension notes and the "status" assigned (S - local students, P - commuter students, F - long distance students).

Long distance students who provided a rental contract must immediately communicate to Diritto allo studio office any change in the rental documents.

First-year students enrolled in the **first year of the bachelor's degree and master's degree cycle** in order to be definitively eligible must pass the OFA and achieve 35 CFU, also by using 5 CFU bonus, within August 10th, 2026.

The freshmen's students **of the master's degree**, in order to be definitively eligible must achieve 20 CFU within August 10th, 2026.

N.B: the number of CFU is intended to be halved for part-time students.

The achievement of these credits by **November 30th**, **2026** will entitle the **beneficiaries** to receive a grant equal to 50% of the value provided for in the call.

NUMBER OF THE SCHOLARSHIP

As stated in the **Bando di concorso** we allocated **800** scholarships. If the University gets extra money from the Lombardy Region, we will publish a notice on the Borse di Studio webpage around July 2026.

PAYMENT METHODS FOR SCHOLARSHIPS

FIRST INSTALLMENT PAYMENT:

A) BENEFICIARY students - ENROLLED IN A 1st YEAR

- WHEN: LIKELY by 31/12/2025;
- **WHERE:** to the personal IBAN indicated by the students by 09/12/2025 in their Sportello Internet Studenti>Home> Conto rimborso contributi-pagamento Borse di studio or, in the absence of it, to the IBAN associated with the Flash up University Card provided by the university *;
- **HOW MUCH:** half of the gross amount indicated in the announcement, less deductions for the free meal and (possibly) accommodation.

B) BENEFICIARY students - ENROLLED TO THE YEARS SUBSEQUENT TO THE 1st YEAR

- WHEN: LIKELY by 31/01/2026;
- **WHERE:** to the personal IBAN indicated by the students by 09/12/2025 in their Sportello Internet Studenti>Home> Conto rimborso contributi-pagamento Borse di studio or, in the absence of it, to the IBAN associated with the Flash up University Card provided by the university *;
- **HOW MUCH:** half of the gross amount indicated in the announcement, less deductions for the free meal and (possibly) accommodation.

C) BENEFICIARY students - OUT OF COURSE (FUORI CORSO)

- WHEN: LIKELY by 31/01/2026;
- **WHERE**: to the personal IBAN indicated by the students by 09/12/2025 in their Sportello Internet Studenti>Home> Conto rimborso contributi-pagamento Borse di studio or, in the absence of it, to the IBAN associated with the Flash up University Card provided by the university *;
- HOW MUCH: a single intallment of the half of the net amount indicated in the announcement.

SOSPESI BENEFICIARI students with suspension notes will receive the scholarship in a single payment starting from July 2026, if the reasons for suspension no longer exist.

*WARNING: beneficiary students who have not entered any IBAN in in their Sportello Internet Studenti > Home > Conto rimborso contributi-pagamento Borse di studio_by 09/12/2025 have the possibility of entering an IBAN in their Sportello by 31/01/2026 and will receive the scholarship study in a single solution starting from July 2026.

If the student, WHETHER ELIGIBLE OR BENEFICIARY, does NOT provide the payment details by January 31, 2026, he or she will lose the scholarship benefit for the 2025/2026 academic year.

SECOND INSTALLMENT PAYMENT:

The **second installment** will be paid **to BENEFICIARIES enrolled in years subsequent to the first** likely by the end of July 2026.

Students enrolled in the first year of a three-year or single-cycle master's degree will receive the second installment after passing the OFA and obtaining the minimum CFU required to confirm the scholarship for the academic year. 2025/2026.

Students enrolled in the first year of a master's degree will receive the second installment after obtaining the minimum ECTS required to confirm the scholarship for the academic year 2025/2026.

All the criteria and information on the payment of the scholarships are specified on page 22 and following of the Scholarships Call for Applications.

CANTEEN

The assignment of the benefits to the eligible and to the beneficiaries of the scholarship will be recognized from 1st January 2026 to 31st December 2026, by using the Qr Code created by the Canteen App Unibg.EAT.

Eligible freshmen (Idoneo) can receive the daily free meal (drinks excluded) **after** they will pass the credits required to confirm the scholarship for a.y. 2025/2026 as indicated above.

Beneficiary freshmen, and all eligible and beneficiary students enrolled to a year subsequent to the first can have the daily free meal (drinks excluded).

Suspended beneficiary freshmen and students enrolled to a year subsequent to the first and suspended eligible students enrolled to a year subsequent to the first can receive the daily free meal (drinks excluded) after the reasons for suspension no longer exist.

TAX EXEMPTION

All students enrolled in subsequent years, who are beneficiaries or eligible for the 2025/2026 scholarship, are entitled to a waiver of the comprehensive tuition fee without the need to confirm additional merit requirements.

Eligible students enrolled outside the prescribed timeframe **(fuori corso)** are entitled to a 50% waiver of the comprehensive tuition fee.

For first-year students who are beneficiaries or eligible for the 2025/2026 scholarship, the waiver of the comprehensive tuition fee is contingent upon achieving, by August 10, 2026, the following:

- 35 credits (ECTS), including the use of the 5-credit bonus for students enrolled in the first year of a bachelor's degree or single-cycle master's degree.
- 20 credits (ECTS) for students enrolled in the first year of a master's degree.

Obtaining the aforementioned credits by **November 30, 2026**, instead of **August 10, 2026**, will entitle you to a 50% exemption from the payment of the comprehensive contribution.
