



## LAST DEFINITIVE RANKING SCHOLARSHIP ACADEMIC YEAR 2025/2026

The Last Definitive Ranking for the Academic Year 2025/2026 Scholarship has been published.

Thanks to the funding received, all applicants who submitted an application and meet the requirements set out in the call for applications have been awarded the scholarship.

### HOW TO CHECK THE RESULT

1. Access the [Portale del Diritto allo studio](#)
2. Go to "Esito Graduatorie"
3. Click on "Visualizza esito" next to "Borsa di Studio - Graduatoria Definitiva Integrata a.a. 2025/2026"
4. Carefully check any suspension notes and the assigned "status":
  - S = resident student
  - P = commuting student
  - F = non-resident student

Any requests for corrections or appeals must be submitted by **June 12, 2026** through a [Ticket](#) to the Servizio Diritto allo Studio.

For privacy reasons, information regarding the ranking will be provided exclusively to applicants.

### MERIT REQUIREMENTS FOR FIRST-YEAR STUDENTS

To confirm eligibility for the scholarship for the academic year 2025/2026, first-year students must:



- **Bachelor's and Single-Cycle Master's Degree students:**
  - Pass any OFA (Additional Learning Requirements)
  - Earn **35 ECTS** by **August 10, 2026** (5 bonus ECTS credits available)
- **Master's Degree students:**
  - Earn **20 ECTS** by **August 10, 2026**

For part-time first-year students, the required ECTS credits are reduced by half.

First-year students who obtain the required credits by November 30, 2026 will be entitled to 50% of the scholarship.

**It is not necessary to submit any form to certify the achievement of ECTS;** all criteria and information regarding scholarship payments are specified on pages 22 - 23 of the [Call for Applications for the academic year 2025/2026](#).

## SCHOLARSHIP PAYMENT

Eligible students **enrolled in years following the first, and first-year students who have the credits indicated in the previous paragraph officially registered in their academic record by June 15, 2026**, may receive the scholarship payment:

- **WHEN:** by the end of July
- **WHERE:** to the bank account indicated by the student in the Online Student Portal under Menu > Home > Master Data > **"Data bank account (Refunds)"**
- **AMOUNT:** the net amount provided by the call for applications according to the student's status and income bracket, minus any first installment already received

Students enrolled **beyond the standard duration of their degree program** (fuori corso), already included among the beneficiaries in the December ranking, have already received the full amount due.

Students with a **suspended** status will receive the amount once the reasons for the suspension have been resolved.



## **UNIVERSITY CAFETERIA**

Free meals are assigned automatically by the Student Financial Aid Office: students must show the QR Code generated by the [App Unibg.EAT](#) at the cashier.

Students with a suspended status will be able to access free meals once the reasons for the suspension have been resolved.

## **EXEMPTION FROM TUITION FEES**

- Students enrolled in years following the first, who are scholarship beneficiaries, are entitled to full exemption from the all-inclusive tuition fee;
- Students enrolled beyond the standard duration of their degree program, who are scholarship beneficiaries, are entitled to a 50% exemption from the all-inclusive tuition fee;
- For first-year students who are scholarship beneficiaries, exemption from the all-inclusive tuition fee is subject to obtaining the ECTS credits required by the call for applications. Obtaining the credits by November 30, 2026 grants a 50% exemption.
